Facility Use Waiver of claim, Assumption of Risk Indemnity

In consideration of permission to enter and use High River Agricultural Society’s lands, premises and facilities the undersigned user hereby agrees as follows:

The User agrees that the High river Agricultural Society (“the Society”) will not be liable or responsible in any way for any personal injury that may be sustained by the User or any agent, employee or servant of the User, or of any other person who may be upon the lands or for any loss of or damage or injury to, property belonging to or in the possession of the User or any agent, employee or servant of the User, or any other person and without limited the generality of the foregoing, the Society will not be liable or responsible on any way for any injury, loss or damage to person or property of any nature or kind arising from the User’s use and occupation of the Society’s lands and facilities or otherwise.

GENERAL INDEMNITY

It is understood and agreed that by using the High River Agricultural Society’s lands and facilities that all Users of these facilities acknowledge that all animal activities involve inherent risk of personal injury, death and property damage. The User hereby expressly agrees to indemnify and save harmless the Society, its Directors, Agents, Servants, Volunteers, Sponsors, Competitors and Members from and against any and all liabilities, damages, costs, including solicitor and client costs, expenses, causes of action, actions, claims, suites and judgements which the Society, its Directors, Agents and Servants may incur or suffer or be put to by reason of or in connection with the use and occupation of the Society’s lands and premises by the User and without restricting the generality of the foregoing arising from:

Any damage to property of the User, and all persons claiming through or under the User, or any of them, or damages to any other property howsoever occasioned by the condition, use occupation and maintenance of the Society’s lands and premises;

Any injury to any person including death resulting at any time during the term hereof, occurring in or about the Society’s lands and premises and;

Any wrongful act or neglect of the User and its invitees in and about the Society’s lands;

And furthermore, such indemnification will survive any termination of the User’s use and occupation of the Society’s lands and premises.
